**INVITATION TO BID**

1. The Cabagan Water District (CWD) has an approved Program of Work amounting to **P 3,904,104.00** from the CWD Corporate Operating Budget Approved by the Board of Directors for the Drilling of Two(2) Production Wells.
2. The CABAGAN WATER DISTRICT THROUGH ITS Bids and Awards Committee (BAC), now invites bids for the Drilling of Two (2) Production Wells. Completion of work required within Ninety (90) calendar days after receipt of Notice to Proceed. Bidders should have completed, within five (5) years prior to the date of submission and receipt of bids, a single largest completed contracts (SLCC) similar to the project, equivalent to at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II "Instruction to Bidders". Bids submitted exceeding the relevant Approved Budget for the Contract shall be rejected.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. All particulars relative to eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of RA 9184 and its Implementing Rules and Regulations (IRR).
